1. BYLAW NO. 4669

Purpose To discharge Land Use Contract No. 3 and permit the use of land for multiple school buildings.

File No. ZON00003

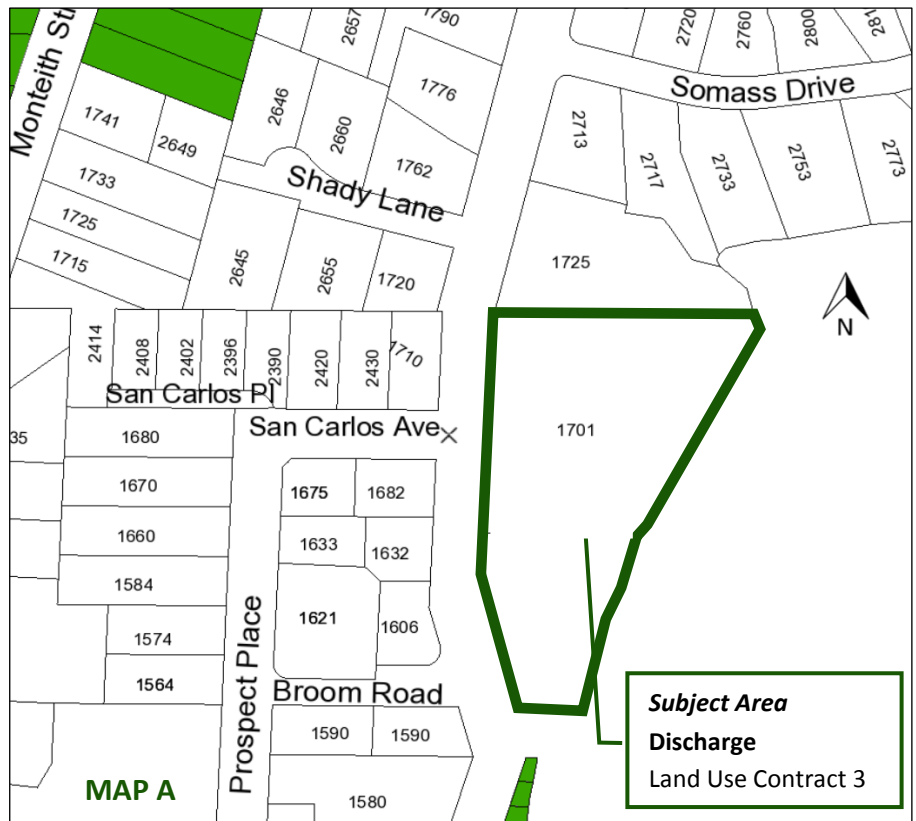

PLEASE NOTE

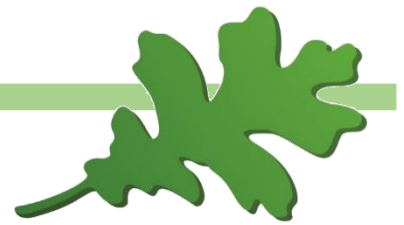
