Agreement (HRA), and retain the existing heritage designated home on the southerly lot.


Location(s) 2031 Runnymede Avenue (see Map A)

This bylaw to implement a Heritage Revitalization Agreement (HRA), if adopted, will facilitate a two lot subdivision of the site with one new single family dwelling located on the northerly lot, and the existing heritage designated home and secondary suite retained on the southerly lot. The HRA will:

- relax Zoning Bylaw requirements by permitting a secondary suite within the heritage home; and
- relax Zoning Bylaw requirements by varying Lot Width for the northerly lot from 21.34 metres to 18.74 metres.

The subject area is legally described as Lot E, Section 47, Victoria District, Plan 9191.
