Mayor Jensen called the meeting to order at 5:36 p.m.

COMMUNICATIONS:

1. 2016 Municipal Budget

• Report – Director of Financial Services – April 13, 2016

Acting Director of Engineering Services, D. Brozuk

• Report – Director of Financial Services – April 5, 2016

MOVED and seconded: That the memorandum dated April 13, 2016, from the Director of Financial Services regarding the 2016 Municipal Budget be received for information.

CARRIED

It was noted that the memorandum outlined a proposed reduction in the overall municipal tax lift to 2.79 per cent from the 3.19 per cent considered at the last meeting, arising from changes made in departmental information. Staff confirmed that these reductions would lower the potential increase in the municipal portion of the tax lift to 2.22 per cent, and, after factoring in the solid waste charge, the potential lift would be 2.20 per cent.

2. Oak Bay Volunteer Services Society (OBVSS)

• Verbal Update – Executive Director, OBVSS – April 13, 2016

At the invitation of the Chair, Joan Halvorsen, Oak Bay Volunteer Services Society, <u>Executive Director</u>, made a brief presentation to the Committee, noting that further funding sources had been identified for certain aspects of the society's programming, but that the society would still like to receive the \$10,000 requested from the District to maintain programming.

Ms. Halvorsen responded to questions from the Committee, confirming that the proposed funding arrangement to include the Better at Home program in the offerings of the society will be referred back to the Board, but clarified that it was her understanding that this would not reduce the society's programming costs. She also confirmed that the society has pursued TechSoup to potentially address future capital costs related to technology.

3. Departmental Budgets (Operating and Capital)

Engineering and Public Works Operating and Capital Budget:

The Acting Director of Engineering Services responded to questions from the Committee in respect to the departmental operating and capital budgets.

Discussion ensued regarding the District's infrastructure deficit and the status of its reserve funds. Ms. Carter noted that reports will be coming forward later in the year regarding the status of reserve funds and an asset management plan. Council discussed the best method of reviewing and potentially increasing reserve funds in order to maintain the District's assets.

4. *Revenue Sources*

Discussion ensued regarding the sources of revenue available to the District, including the grant in lieu of taxation paid to the District by the Province for the University of Victoria lands, the cost of business licenses and enforcement thereof, and the revenue generated by expired building permits.

5. *Referrals to Estimates Committee*

Discussion ensued in which the Committee undertook a review of the following referrals:
