Nancy Richards reviewed the vision for the school and the need for a new facility.

Paul Merrick presented the proposal for the redevelopment of the St. Michael's University School which they have been working on for over 2 years, he said. Part of the proposal includes retaining the Oak trees on the property, adding 35 parking stalls underground and 10 parking spots at the street level to accommodate drop off and pick up of students.

Gary Pooni reviewed the public consultation that has taken place which included 4 Open Houses. He said that the process to develop the Master Plan took 13-14 months noting that parking and traffic were identified as problems that required long term solutions. The plan is to create a design that is respectful to the community, he said.

Nancy Richards then addressed a number of concerns from the neighbourhood that were identified in letters received by the Committee in regard to enrolment, after school programs, traffic issues and water drainage. She also reviewed other initiatives to help with neighbours concerns including staggered timetables to help with drop off and pick up of students.

A discussion ensued with members of the Committee in regard to the proposal, public consultation and landscaping. There was some concern expressed regarding the parking and traffic issues, and members of the Committee discussed the possibility of requesting a traffic study.

Michael Conrad, resident, expressed concerns with the parking and traffic in the immediate area.

<u>Michael Bullock, resident,</u> said he is sympathetic to the parking issue of the neighbours. He has concerns with the lack of communication from the school noting he was unaware that a wall is proposed along the property line where his property abuts the school property.

<u>John Nedwidek</u>, resident, commented that access to the property should be from all points possible and suggested that Faulkland Road should also be considered. Mr. Nedwidek also said he is concerned with traffic and parking issues.

<u>Chris Strong, resident,</u> said he is concerned with putting the school closer to the neighbouring properties and that he feels it will have a negative effect on property values. He also noted his opposition to the setback on the north side.

Taryn Scott, resident, said she is concerned with the drainage of water from the property.

The Director of Building and Planning said that there will be rain gardens and any overflow from which will be pumped into the storm drain system.

<u>Robin Longe</u>, resident, said he is opposed to the development. He feels the development does not fit in the neighbourhood and the impact would be excessive and he is concerned with traffic and parking issues.

<u>Natalie Longe</u>, resident, noted her concerns that no parking/traffic plan has been done for the proposal. She said she has concerns with safety issues surrounding drop off and pick up of students.

Margo Ross, resident, lives adjacent to the school and said she supports the project.

<u>Michael Modesly, resident,</u> said he is is supportive of the project and commented that it will come within 30 feet of his house.

<u>Frances Thorson, resident</u>, said she lives on the north side and is not upset with the school plan but with the community letter that was sent to Council because it was not circulated to anyone that lived on Falkland Road.

<u>Bonnie Robinson, resident</u>, said she feels the school is sincere in its efforts to accommodate the issues presented and she feels that not having a traffic plan is a valid concern.

<u>Parminder Basron, resident,</u> said he did not know about the open houses and feels there is not much evidence of community leadership from the school. He has concerns with traffic and parking.

<u>Sharin Alum, resident,</u> said that prior to 2011-2012 communication from the school was poor and that is the frustration of the neighbourhood. She supports requesting the school obtain a traffic management plan.

<u>Jason Scully, grade 11 student</u>, said if the Junior school could have the upgrades it will make the students education a great experience, like he has enjoyed as a St. Michael's University School student.

<u>Bob Snowden</u>, <u>Head of School at St. Michael's University School</u>, said they recognize that people are unhappy with the parking and traffic problems at the school and the redevelopment of the school will be an improvement. The variances requested allow for more parking and preservation of the Oak trees. They would be interested in undertaking a traffic study, he said.

Carolyn Stevens, resident, said she would like something done regarding the traffic situation.

<u>Colin Chadwick, resident,</u> said that if they had residential parking only on Beaverbrook Street it would solve their problems.

Michael Bullock, resident, said the traffic and parking issues have put neighbours against each other and street against street.

<u>Michael Conrad, resident,</u> said other schools have more parking and he gave examples. He encouraged the school to look at other access points, like Falkland Road.

<u>Chris Strong, resident,</u> reminded everyone that the meeting is to discuss variance setbacks which place the school closer to his property, therefore he is one of the most affected.

<u>Gary Howard, resident,</u> said he is concerned with the setbacks and how they will affect his property.

<u>Paul Merrick</u>, said he did not hear these concerns previously and if a traffic plan is wanted it can be done. If there are any concerns he encouraged people to contact him.

<u>Bob Snowden</u>, said if a traffic study is desired by the Committee, they are willing to undertake one.

A discussion ensued in regards to parking and traffic issues associated with the school and the redevelopment proposal. It was felt that the application should be deferred until more information in regard to the specifics of the proposed wall on the north side, a traffic study, options and impacts of revising the setbacks, and/or the rationale for the current setbacks, and renderings depicting the adjacent residential properties have been obtained.
