OI 130 – Police Pursuit and Emergency Vehicle Operation

OI 130 – Appendix A

OA 090 – Emergency Vehicle Operation (rescinding)

There are currently two pieces of policy; Emergency Vehicle Operation-OI 130 that pertains to attending calls for service with lights and sirens and Police Pursuits-OA 090, which pertains to pursuing a fleeing suspect vehicle. Both policies will be combined into one, with the overreaching policy remaining as OI 130, renamed Police Pursuit and Emergency Vehicle Operation. Emergency Vehicle Operation, policy OA 090 to be rescinded. The bulk of the two policies are unchanged and current provincial standards have been incorporated. One section referring to a specific vehicle that is no longer part of the fleet has been removed. Wording has been added that covers breaches of policy and action to be taken in these circumstances.

MOTION: To approve the changes to Policy OI 130 and rescission of Policy OA 090 with the following changes:

- The word "or" inserted into Sec. 3.1, line 3, following the word "indictable"
- The removal of the brackets around "dual procedure" on line 3, Sec 3.1.
