#### MAYOR'S REMARKS:

3. The Mayor provided remarks on the following topics:

## 1st Anniversary of Raising Sno'uyutth Welcome Pole

The Mayor noted that the one year anniversary of the raising the Sno'uyuth Welcome Pole was forthcoming, commenting on the value that community-led process had played in enhancing collaboration between the District of Oak Bay and the Esquimalt First Nation, the Songhees First Nation, and School District 61. He offered his thanks to the Rotary Foundation and the Community Association of Oak Bay, as well as the many community volunteers for their involvement.

## Canadian Mental Health Association BC Division - #B4STAGE4 Conference

Mayor Jensen stated that he was honoured to participate in the announcement last Friday by the Canadian Mental Health Association of their upcoming three-day conference on the need for improved access to mental health services, particularly noting the need for addressing addiction as a mental health issue.

## Grants-in-Lieu - Ongoing Challenges

The Mayor drew attention to recent correspondence received from the Minister for Advanced Education, commenting that it was regrettable that no action was being taken to address ongoing issues with the decrease in funding made available through the grants-in-lieu process.

## Association of Vancouver Island Coastal Communities Conference - Call for Resolutions

Mayor Jensen noted that the call for resolutions was under way for the upcoming 2017 Association of Vancouver Island Coastal Communities Conference.

### Remembrance Day - Oak Bay Cenotaph Task Force

The Mayor commented on the moving Remembrance Day celebrations he had attended at local schools and the Oak Bay Cenotaph, offering thanks to Councillor Ney and the Oak Bay Cenotaph Task Force for the compliments received regarding the ceremony. He concluded his remarks by highlighting "School District 61 Remembers...." created by the School District Archivist Judy Stevenson which has been provided to Oak Bay Archives.

### 4. The following speakers addressed Council during the Public Participation Period:

<u>Rod Sim, Oak Bay Rotary Foundation</u>, spoke to Council on the Sno-uyutth Legacy Scholarship, noting that the scholarship had been created through the Sno-uyutth Welcome Pole fund raising process. Mr. Sim commented that the Foundation is asking for Council's support to increase the annual scholarship amount and expand the scholarship availability to include Greater Victoria.

<u>Vivian Smith, Oak Bay resident</u>, noted that as a long-term resident who grew up in the community she was concerned regarding the issue she had faced with renovating her house and expressed concerns regarding the District's response to her concerns.

to accommodate renovations and additions to an existing heritage property, the Glenlyon Norfolk School, as shown on the plans appended to the October 24, 2016 Council agenda item number 8, being a report from the Manager of Planning dated October 17, 2016.

<u>Naomi Pope, Oak Bay resident</u>, commented on the proposed redevelopment of 1701 Beach Drive, expressing her concerns regarding consultation and the potential impact on views through the site as further outlined in her correspondence attached to the agenda. She noted that residents involved with the potential Heritage Conservation Area nearby were unaware of the status of this redevelopment. Ms. Pope concluded her comments by noting that it was her intention to voice her concerns and to take this opportunity to work collaboratively with the proponent to enhance the architecture.

<u>Karen Wallace-Prince, Oak Bay resident</u>, stated that she was unaware that the proposed redevelopment of 1701 Beach Drive was at this stage of the process. Ms. Wallace-Prince commented that her family had loved having students attend the campus of Glen Lyon Norfolk school and that the renovations were badly needed. She expressed concerns about relocation of the coach house, the impact of blasting on the neighbourhood and on heritage dwellings and emphasized that the heritage dwellings on site were an anchor to the neighbourhood. She concluded her remarks by commenting that she would like an opportunity for further consultation with the school on the proposed redevelopment.

<u>Chris Denford, Board Chair of the Glen Lyon Norfolk School Society</u>, outlined the engagement process taken over the last year and a half with respect to the application, clarifying that the plans commented on by Ms. Pope were in regards to the phasing process and noting that the design plans had been made available to the community during this time.

<u>Christopher Rowe, Architect</u>, responded to questions and comments regarding the proposed redevelopment. Mr. Rowe clarified that the amount of blasting required was still to be determined, but that a process to contact residents regarding the impact was still forthcoming. He then commented on the proposed streetscape, noting that the original intent had been not to make a strong statement, but rather to highlight the heritage dwellings while still addressing privacy impacts of adjacent residents and the students on site. Mr. Rowe further clarified that the requested variance was not with respect to height and that the proposed development would in some areas be lower than the existing dwellings. He concluded his remarks by noting that the roof line was pitched not a continuous straight line.

WHEREAS, nothing is to prevent Council or staff from making last minute changes or additions to the agenda as per normal District process and procedures:

THEREFORE BE IT RESOLVED, that staff prepares the necessary documentation and notice to amend Bylaw No. 4052, the Bylaw to regulate the proceedings of the Municipal Council of The Corporation of the District of Oak Bay (\*\*amended by Bylaws No. 4088, 4203, 4278, 4479, 4565, and 4657), as follows:

For Section 10 relating to the Agenda, which currently read as,

10. The Municipal Clerk shall prepare an agenda for each meeting of Council or a Committee and shall deliver a copy of the agenda, with supporting documents, to each member of Council or the Committee, at least 24 hours before the meeting

that the notice be increased from 24 to 72 hours; and

For Section 15 relating to Meeting Notice, which currently reads as,

15. At least 24 hours before a meeting of Council or a Committee of Council, the Municipal Clerk shall cause a Notice of Meeting to be posted at the places hereby designated as public posting places within the meaning of the legislation governing local government in British Columbia, being the outside notice boards located on the north and south facades of the Oak Bay Municipal Hall, with such notice to include the time, date and place of the meeting

that the notice be increased from at least 24 to at least 72 hours, with the expectation being that the website will be updated in a similar timeline.
