1. Call to order at 5:10 p.m.

- 5. Heritage Applications Referred by Municipal Council:
 - 5.1. 2090 Byron Street (a package of information was circulated, plus photos of the house): There is a request for an alteration to a building on the Heritage Register that was built in 1893. The homeowner wants to add a deck to the back of the house.

MOTION: to recommend to Council that the alteration be approved, and that the owner consider suggestions for symmetry of the windows, and railings or pickets around the deck, in order to respect the integrity of the house.

MOTION: to ask owner to come back with a detailed solution with more attention to the details of the door, the railing, and the materials, to be more compatible with the rest of the house, and to avoid cutting into the patterned shingles of the dormer above.
