# IV. UNFINISHED BUSINESS

# Tree Protection Committee Report

Past Tree Committee Chair, Don Farquhar in attendance. To continue its work, the Tree Committee has met several times over the past year and most recently to discuss suggestions for amendments to the Tree Protection Bylaw 4326 as well as tree bylaw offence penalties. As a result of these discussions the Tree Protection Committee recommends the following amendments to Bylaw 4326:

# Interpretation section:

- 'damage' (b) change to place fill or organic waste...
- 'protected tree' (a) add: Black Hawthorne, this tree would also be added to 10 (2) (tree pictured in attachment A)

# **Trees Within Building Envelope section:**

• Currently the building envelope is divided into two lot sizes. A building envelope of a lot size less than 1500 square metres in area and a building envelope of a lot size greater than or equal to 1500 square metres in area. The Committee recommends the bylaw be amended to eliminate section 3 (1) thereby section 3 (2) would apply to all lot sizes. (see attachment B)

# **Permit Issuing Authority section:**

Change 6 (10) to allow a permit to be issued to cut down or damage a protected tree to
promote and protect the health and vigour of a protected tree of the species listed in
subparagraph (a) of the definition of "protected tree" in Section 1 of the Bylaw.

# **Replacement Trees section:**

 Change Section 10(7) and Section 10.1 to increase the security deposits for the care and maintenance of replacement trees for a period of three years from \$500 to \$1,000 (two replacement trees) and from \$250 to \$500 (one replacement tree), respectively.

Commission members were advised of the following:

Total tree permits for all types of work and species that are protected were 257 in 2008, 202 in 2009 and 272 in 2010.

The total number of Garry Oak Trees removed in 2008 were 45, 2009 35 and in 2010 45.

It was suggested that under the interpretation section that the Black Hawthorne include the latin name of *Crataegus douglasii*.

Moved by Rick Marshall, Seconded by Brian Sharp THAT THE PROPOSED AMENDMENTS TO THE TREE PROTECTION BYLAW 4326, INCLUDING THE LATIN NAME FOR BLACK HAWTHORNE, BE RECOMMENDED TO COUNCIL FOR APPROVAL.
