Cards will be issued to each member of an eligible household. <ul style="list-style-type: none"> • The L.I.F.E. 52 Drop In Admissions cards are good for one calendar year and may be used at any Recreation Centre in Greater Victoria. • The seasonal program discounts and the 50% off annual pass option is restricted to use at Recreation Oak Bay facilities only (valid one year from purchase). 2. Once approved, program discount cards must be presented in person at time of registration in order to receive the discount. The discounts provide either 50% off a course \$100 or less or \$50 off a course over \$100.
