# Our Oak Bay

The District is located on the southern tip of Vancouver Island in British Columbia. The City of Victoria borders Oak Bay's west boundary, and the District of Saanich lies to the north. Oak Bay is one of 13 member municipalities comprising the Capital Regional District. The University of Victoria is partially located in the District, as is a small portion of Camosun College. Additional community landmarks include other public and independent schools, two golf courses, a marina, a yacht club, and a luxury boutique hotel.

Oak Bay is a beautiful seaside community that is defined by its residential neighbourhoods, village centres with local businesses, historic character, mature tree canopy, accessible shorelines, and abundance of green space. These features combined make Oak Bay one of the world's most desirable communities in which to live, work, and play.





# Message from the Mayor

I am pleased to share Oak Bay's Council Priorities Plan. The identified priority projects build upon the work of the previous Council, which strengthened the critical financial, governance, and operational foundations of the District. The resulting transparency and efficiencies allow Council to consider new projects to improve quality of life for residents and visitors alike.

The Council Priorities Plan and related Five Year Financial Plan provide a roadmap to achieve these goals within a responsible financial framework. # District of Oak Bay Council

The District of Oak Bay's Council consists of a Mayor and six Councillors who are elected to four-year terms. Members of the current Council took office in November 2022. Council is responsible for local government leadership including establishing priorities and policies and making decisions in Oak Bay's best interests. Each member of Council represents the District of Oak Bay at large. Council members may also serve on District and regional committees, boards, and advisory groups where their function is to provide strategic input and direction to District initiatives, establish budget priorities, and provide advice on regional issues. Council generally meets the second and fourth Monday of each month and sits as Committee of the Whole on the third Monday of each month. Members of the public are welcome and encouraged to attend open meetings of Council. Meetings are held in the Council Chambers unless otherwise noted. 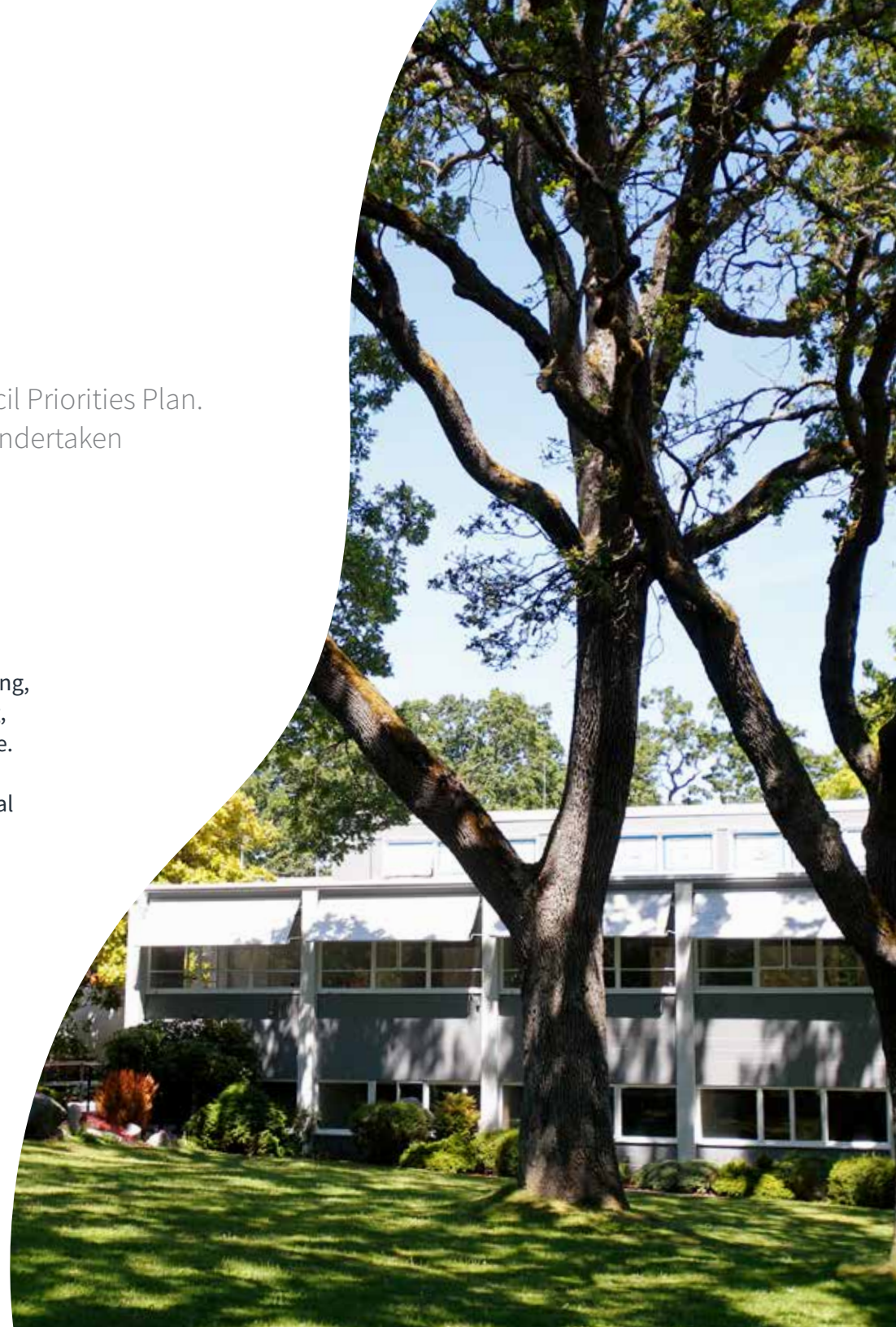
# Introduction

## Leadership

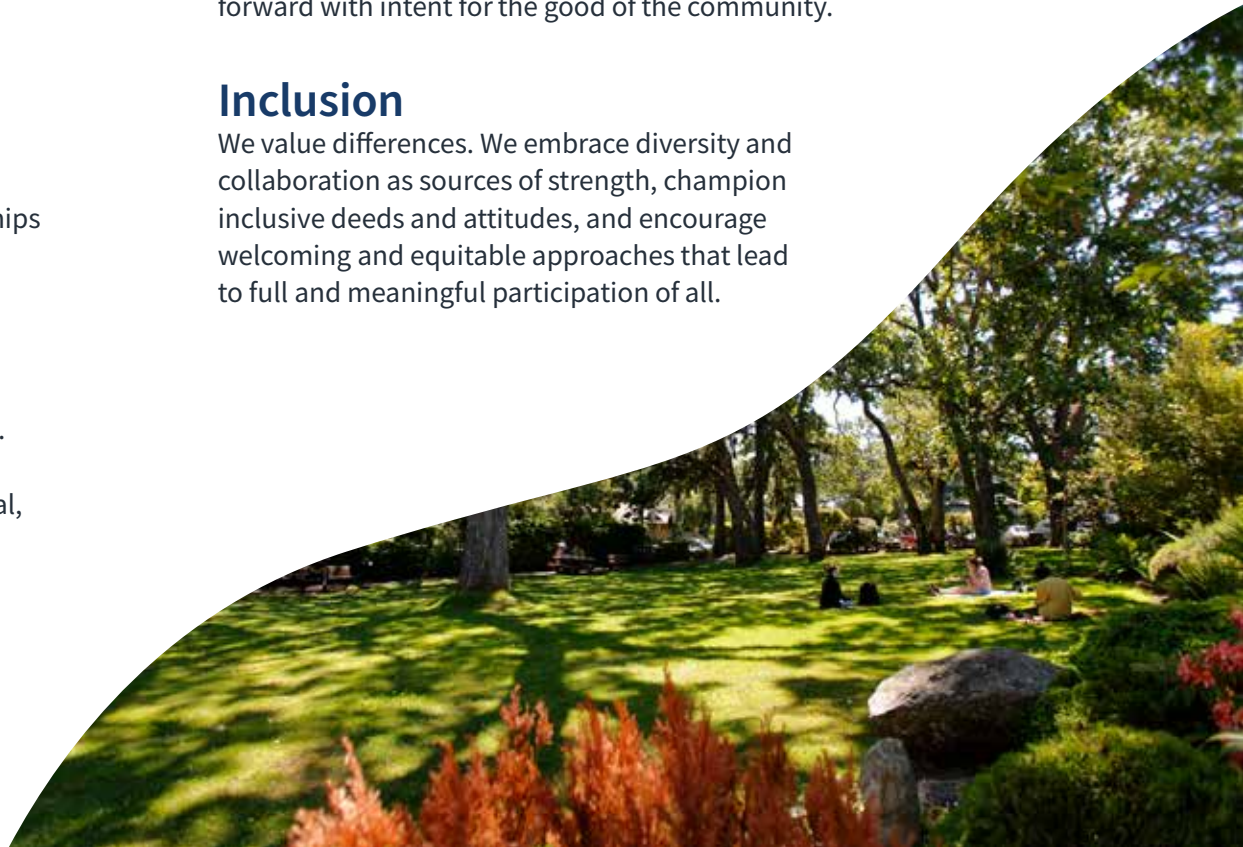

## Housing

Enable creation of more diverse and affordable housing that is responsive to current and future community/regional needs and climate change imperatives



## Livability

Invest in infrastructure, facilities, and natural assets and services to preserve or improve long term financial and community value/livability



## Transportation

Advance low and no carbon, accessible, and active transportation mobility infrastructure and services



## Climate Change & Environment

Enable creation of more diverse and affordable housing that is responsive to current and future community/regional needs and climate change imperatives



## Accessibility, Diversity & Inclusion

Cultivate accessibility, diversity and inclusion and ensure a sense of community belonging and safety for people of all abilities, identities, ages, and backgrounds



## Truth & Reconciliation

Advance Truth and Reconciliation with local Indigenous peoples based on respect and desire for shared prosperity



# Funding

Most of the annual budget is devoted to delivering on current commitments. Completing new projects often requires specialized expertise (consultants), additional staff resources, and/or additional financial resources (funding public engagement and other project expenses). Through the Five-Year Financial Plan and annual budget process, Council considers whether/how to fund new projects to further advance identified priorities.

The new projects itemized on the following pages are those which Council has approved in the Five-Year Financial Plan. Project implementation will depend on sufficient funding being available to carry out new projects. The Five-Year Financial Plan reflects anticipated project costs. If costs escalate due to scope changes and/or inflationary pressures, budgets will have to be increased to allow projects to proceed. Through the annual budget process, staff will identify whether the amounts identified in the Five-Year Financial Plan are sufficient to carry out projects planned for the following year. Where changes are needed, such will be flagged for Council's consideration. As Council annually decides which projects to fund and at what level, the Council Priorities Plan will be adjusted accordingly.

The Council Priorities Plan is thus a 'living document' that is subject to change based on Council direction, but that at any time captures most current directions/plans.



# Overview of the Council Priorities Plan

The District of Oak Bay's Council Priorities Plan identifies for completion projects that Council has approved for funding.

A Council Priority project is a project that directly supports achievement of a Council-identified priority theme area; AND is above all a project [i.e., not part of core operations, not a work activity (including construction), not a program, etc.] AND usually satisfies at least three of the following four criteria:

- lasts more than a month, with more than 2-3 staff and/or consultants involved; or
- required(s) Council project budget approval (i.e. not part of core operating budget); or
- requires significant community-wide or multiple stakeholder consultation or engagement;
- or requires Council authorization to implement.
- OR is an ongoing increase in service level.

Importantly, the projects noted in the Council Priorities Plan do not constitute the entirety of the organization's efforts. In addition to the projects in the Council Priorities Plan, District staff have responsibility for ensuring that regulatory obligations are met; that core services are delivered; and that systems, processes and customer service are continually enhanced.

The Council Priorities Plan is flexible. To remain relevant, the projects associated with each Council Priority are refreshed annually. Those projects included in the Council Priorities Plan are seen by Council as critical to advancing one or more priorities and have been approved for funding. Some projects will be completed in a single calendar year, whereas others will be completed over several years. This Council Priorities Plan is one component of Oak Bay's Council Priority Planning Process – a system that integrates planning, budgeting, reporting, and feedback processes. This integrated system is designed to ensure that public funds are allocated to top community priorities, invested effectively, and spent efficiently to deliver valued services that achieve the community's vision.

# Funded Projects

The following pages list projects which Council has funded in the Five-Year Financial Plan and directed staff to implement.

The list notes the year in which funding will be provided. Staff will, in the year in which funding is provided, prepare Project Charters and obtain Council Project Sign-off prior to proceeding, where noted in the following pages. Council Project Sign-Off is typically required for larger projects where there are multiple ways that a project can be scoped or approached and additional Council direction is required on details such as deliverables, milestones, consultation/engagement opportunities, and success criteria before a project can be started. Council will confirm project scope and timing through the Project Sign-Off. Once Council has signed off on project details, then the agreed-upon targeted timing will be noted in the following pages. Project timelines, where provided, are best estimates. Timing may need to be adjusted to deal with emergencies, balance workloads, coordinate with partners, benefit from grants, provide for additional community consultation etc.

For projects listed for funding in years beyond Council's current mandate, completion will be subject to confirmation by a future Council.
