RESULTS SUMMARY District of Oak Bay 2025 Community Feedback Questionnaire

August 18, 2025

PREAMBLE

The District of Oak Bay is pleased to present the results of the 2025 Community Feedback Questionnaire. The questionnaire asked Oak Bay residents and business owners about their experiences with the District's services and staff, and priorities for the future. Responses help the District better understand the community's needs and how they can best be met.

This year, the District received 1,136 responses – this compares to 1,268 received in 2024, and 881 in 2023. For 2025, the number of responses may have been impacted by the concurrent, community-wide questionnaire for the Official Community Plan update. The District sincerely appreciates the time and effort taken by all respondents to share their thoughts and opinions.

Quick Facts About the 2025 Questionnaire

- The questionnaire was launched May 12, 2025 with a deadline of July 2, 2025 this timing once again leveraged an opportunity to promote the questionnaire through the annual property tax mailout
- As in previous years, the questionnaire was promoted in the Oak Bay News, the District's website, June Night Market, social media posts via the District's accounts (no paid advertising as per Council Resolution #2023-408), email to community associations and newsletter subscribers (connect.oakbay.ca), and references in the Mayor's remarks at Council meetings
- This year, staff made additional efforts to reach more renters, as well as youth in the 18-24 age group as both populations have, in recent years, been underrepresented in the Community Questionnaire results. Outreach included:
 - o a postcard mailout with distribution to 7,044 homes/apartments (Canada Post 'admail', at a cost of \$2280)
 - o posters at Oak Bay recreation centres
 - o outreach to local property management groups
 - local school newsletters
- Paper copies of the 2025 questionnaire were available by request at all Recreation Centres and Municipal Hall
- A total of 1,136 valid responses (met the qualifications in the 'screening' question Q1) were received, including 89 paper responses, which were subsequently entered in the online database
- The questionnaire was not a random-sample survey and cannot be considered statistically significant; however, it does provide an indication of the preferences of those who responded to the questionnaire

About the Respondents

- Respondent characteristics are nearly identical to the 2024 Questionnaire results
- 52% reside in North Oak Bay; 46% reside in South Oak Bay
- Most (72%) have lived in Oak Bay for 10 or more years
- The majority (85%) live in a house, and 93% own their home
- 73% are 55 or older and a similar portion (75%) do not have any children aged 18 and under living in their homes (refer to results for Question 29 for a comparison of respondent age categories to the 2021 census)
- Additional outreach efforts were met with only limited success, with a marginal increase in respondents who are renters (5.4% compared to 3.2% in 2024) and a slight decrease in youth respondents (.2% compared to .5% in 2024). Notably, a review of the 2024 District of Saanich community "pulse check" survey shows similar challenges reaching renters and youth, despite undertaking a closed, random-sample survey with a Financial Plan project budget of \$30,000. Of the 2024 closed survey respondents (1,791 in total), 1% were youth in the 18-24 age group, and 7% were renters

Results Highlights - Qualify of Life

- When asked about the overall quality of life in Oak Bay, just over 95% of respondents said the quality of life is good, including 67.3% who said it is very good. Only 1.5% of respondents said it was poor or very poor
- 87% of respondents reported feeling good about living in Oak Bay and 79% agreed that they feel a sense of belonging in Oak Bay
- Most respondents (66.3%) felt the quality of life in Oak Bay stayed the same over the last year, while 27% felt it had worsened within this category of results, this particular statistic yielded the largest difference from 2024, when 23% felt the quality of life had worsened over the previous year

Results Highlights - Municipal Services

- More than 7 in 10 respondents were satisfied with:
 - o parks (80.7% satisfaction)
 - o garbage pickup (80% satisfaction)
 - o design and maintenance of public spaces (79.6% satisfaction)
 - o green bin pick up (79.4% satisfaction)
 - o recreation facilities (74.6%) and
 - o policing (71.2% satisfaction)
- The highest levels of dissatisfaction were reported for road pavement maintenance (45.3% dissatisfied), road lines & markings (31.7% dissatisfied), and sidewalk maintenance (31.2% dissatisfied)

- Solid waste services, including garbage, green bin, spring yard waste, fall leaf pick-up and the Elgin Rd transfer station all rated favourably, with satisfaction rates ranging from 65% to 80%
- Within emergency services, results suggest an opportunity to improve public awareness of the Fire Safety education program and Emergency Preparedness program (63.5% and 45.4% indicated 'don't know / no opinion', respectively)
- Over half (58%) of respondents reported that District services meet their needs

Results Highlights - Communicating & Interacting with the District

- Communications: at 46% and 47% respectively, nearly half of respondents reported being satisfied with Communications (informing) and Community engagement (seeking input)
- Over the past year, respondents were most likely to have interacted with the District through the municipal website, with 15% reporting that they use the website at least one per month
- Nearly half (49%) indicated that they feel Oak Bay welcomes community involvement, and 52% reported they know who to contact if they have a question or comment about District services
- 70% of respondents indicated that email is the best method for the District to communicate information to them, while online communication (oakbay.ca / connect.oakbay.ca) was ranked a close second at 63% - these preferred methods of communication were also the top two preferred methods in the 2024 Community Questionnaire
- In terms of what type of information they'd like to receive, general Oak Bay news / Council updates topped the list at 84%, followed by infrastructure improvements/updates (79%) and housing/development at 77% these information interests were also the top three in the 2024 Community Questionnaire

Results Highlights - Perceptions of Staff

- During the past year, 6 in 10 respondents contacted the District with a question, problem or complaint. The most common reason they were in touch was regarding bylaws, a bylaw infraction or enforcement
- Thinking of their most recent contact, a majority of respondents agreed with positive statements about staff, with the highest levels of agreement for:
 - o 76% agreed staff treated me with courtesy
 - o 67% agreed I could easily find out who I needed to approach
 - 64% agreed staff were knowledgeable
- These same three service statements also garnered the highest levels of agreement in the 2024 Community Questionnaire, albeit with slightly more favourable ratings

Recognizing that customers may not always receive the answer they were hoping for, results indicate an opportunity for improvement related to customer service training and tools, with 28% of respondents reporting they were dissatisfied with the service provided, 31% of respondents reporting they did not receive the service being sought and 35% reporting their main issue was not resolved

Results Highlights - Financial Value

- 42% of respondents indicated they receive good or very good value for property taxes paid
- Respondents are fairly split on whether District services are delivered cost effectively with 18% agreeing, 25% neutral and 24% disagreeing
- 36% of respondents agree that District services are delivered on a timely basis and 25% agree that District services are evolving to meet changing needs
- Across the questions in this section, ratings are slightly lower / less favourable compared to 2024

Results Highlights - Projects & Priorities

- 40% of respondents felt Oak Bay Council's priorities reflect their own; however, only 15% agree that Council is achieving their priorities – these results compared to 45% and 16% in 2024, respectively
- In terms of capital projects, respondents rated their top three most important as:
 - Water, sewer and storm drain systems (91% somewhat or very important)
 - o Parks and playgrounds (85% somewhat or very important)
 - o Road reconstruction (82% somewhat or very important)
- Respondents then rated their top three most urgent capital projects as:
 - Water, sewer and storm drain systems (80% somewhat or very urgent)
 - Road reconstruction (64% somewhat or very urgent)
 - Responding to coastal erosion (59% somewhat or very urgent)
- A majority of respondents (45%) would advise Council to limit tax and/or user fee increases and maintain current service levels over increases to expand services (received 24% support), implementing new user fees for services currently paid through taxes (received 17% support) and/or decreasing with reduction in services (received 7% support)
- Walking/wheeling (includes wheelchairs / wheeled mobility aids, etc.) was reported as the
 most common form of transportation, with 60% of respondents indicating they walk
 or wheel at least once a day, followed by travel by passenger vehicle at 46%. Public
 transit had the lowest participation rate with 51% of respondents indicating they
 never take transit








3) In the past year, do you feel that the quality of life in Oak Bay has . . . 1087 respondents


4) How dissatisfied / satisfied are you with the following municipal services?

1025 respondents



























1. Infrastructure Maintenance and Upgrades

A dominant theme across responses was respecting the state of Oak Bay's infrastructure:

- **Roads and Sidewalks**: Widespread concern about potholes, uneven sidewalks, poor repaving quality, and lack of maintenance.
- **Street Lighting**: Requests for improved lighting, especially in pedestrian-heavy areas and intersections.

- **Stormwater and Sewer Systems**: Perception of slow progress, improvements needed to communication on timelines, and coordination with other projects.
- **Construction Delays**: Frustration with prolonged or abandoned projects, need for more regular updates, and more efficient scheduling.

2. Waste Management and Leaf Collection

Many residents expressed concerns with:

- **Garbage Collection**: Missed pickups, a desire for more frequent service, and more communication about schedules.
- **Leaf Collection**: calls for scheduled, timely pickups.
- **Recycling Services**: Desire to maintain and improve the Elgin Road transfer station, including better staffing and clearer rules.

3. Bylaw Enforcement and Municipal Responsiveness

- **Bylaw Enforcement**: Perceived need for more proactive enforcement, especially regarding parking, off-leash dogs, noise, and property maintenance.
- **Staff Engagement**: Desire for more responsive communications and enhanced customer service
- **Transparency and Accountability**: Requests for clearer updates on project progress, budget allocations, and staff performance.

4. Parks, Recreation, and Public Amenities

Residents highlighted both appreciation and areas for improvement:

- **Recreation Facilities**: Calls for upgrades to the Rec Centre, Carnarvon Park, and Willows Beach amenities.
- Public Washrooms: Requests for more and better-maintained facilities, especially along popular walking routes.
- **Programming**: Desire for more youth and family programs, better registration systems, and equitable access.

5. Active Transportation and Traffic Management

Opinions were divided but strong:

- **Bike Infrastructure**: Strong support from some for expanded bike lanes and safer cycling routes; others opposed due to cost and impact on parking.
- Pedestrian Safety: Requests for more crosswalks, flashing lights, and sidewalk improvements.

• **Traffic Calming**: Concerns about speeding, poor visibility, and unsafe intersections; suggestions included speed bumps and better signage.

6. Housing and Development

- **Densification**: Mixed views on multiplexes and infill housing; concerns about neighborhood character, parking, and infrastructure readiness.
- **Permit Processes**: Need for more clear, consistent application processes
- **Community Consultation**: Calls for earlier and more meaningful engagement with affected residents.

7. Environmental and Ecological Concerns

Residents raised issues about:

- **Deer and Wildlife Management**: Strong calls for deer population control and better enforcement of dog bylaws.
- Tree Maintenance: Concerns about excessive pruning and lack of species-specific care.
- Beautification and Cleanliness: Requests for better street sweeping, graffiti removal, and weed control.

8. Communication and Engagement

A recurring theme was the need for better communication:

- **Project Updates**: Desire for regular, clear updates via email, social media, and newsletters.
- **Public Input**: calls for genuine engagement and responsiveness.
- **Digital Services**: Suggestions for improved website usability, online booking systems, and automated alerts.

Q19. What improvements to Oak Bay services would you suggest?

I would love to see bi-weekly pick up of garden waste because it encourages people to take care of their yards.

I would like to see more opportunity for input in what happens to building and development in OB.

More stress on infrastructure and less on frivolous projects like Carrick Corridor and inappropriate bike lanes. Better return on improvements for business, i.e. Penny Farthing give away.

Get the bus of Newport. Reroute do to congestion. Tell the bus drivers to stop parking in the middle of the road when they can't get through or get tell the passengers to go door to door looking for the lawfully parked car to move so the bus can pass - yes really!

Focus more on infrastructure needs and upgrades. Focus less on appeasing the small but loud bike lane contingent. If allowing/encouraging secondary suites/multi-home builds, ensure off-road parking is considered, or modify policies to enable impacted residents to adapt.

The infrastructure is really showing its age, and needs work. The municipality is planting more trees, particularly oaks. They do not have enough trucks to pick up all the leaves in a timely manner. Our leaves were not removed until late January.

There are multiple non residents who access the depot at 1771 Elgin Street to get rid of waste material. This is failure in Bylaw management. There are multiple non residents who have received Oak Bay vehicle decals. [Comment removed per District's Moderation Policy] I have had conversations with the Bylaw's officer, the Municipal CAO, the public works management, but non have taken steps to correct the problem. www.obgt.ca.

A staff more responsive to taxpayers' needs.

I plan to be more involved with library and community education through community programs, education to meet people with common interests.

I have submitted four reports since January through the Oak Bay Police regarding graffiti on seawall at McNeill Bay and subsequently followed up with email to district staff as to why no action is taken. I have not yet received a reply.

Quarterly updates on what staff have accomplished with respect to ongoing priorities, plans and achieving targets.

Clear bus stops of snow!

Our Farmer's Market could be improved on. Maybe moved to a grassier area? It would be wonderful to have more garden allotments somewhere,

More transparency with current changes to upland housing development risks. We don't need multiplexes in this community. Develop the major arteries - Cadboro bay road, oak bay road, Estevan and foul bay. Not I social properties in our beautiful area - uplands, south okay bay, North oak bay, Estevan etc. Parking is already a challenge and we have

infrastructure on the main arteries. Leave the single family homes as they are - not 4-6 plexes.

More public toilets

Email notifications of garbage pickup

- 1. Change OBEP focus from earthquake preparedness to climate change preparedness. Better value for the money spent.
- 2. Reduce the food services bills for committees and other "social" events.
- 3. Focus just on the core services stated in the community charter.
- 4. Implement a government efficiency review to streamline services and make them more cost-effective.

For example, remove the Ivy on the north side of Monterey Centre. That would reduce the rat problem. Also the laneways are overgrown and people need to be reminded to trim back their hedges encroaching on the lanes. I am not in favour of structured, concrete bike lanes on existing connecting pathways. Cyclists and pedestrians can share existing paths, using common sense. Do we really need more concrete? It'll destroy the feeling of walking a country lane in an urban environment.

I'd like to see more money in the Police budget. More car and bicycle patrols.

More attention to crumbling roads and sidewalks. Easier phone access to city engineering ,planning and bylaw departments. Better animal control and bylaw enforcement.

Sidewalks have, in several places, been partially overgrown by trees or shrubs. Why is this allowed?

Do we have a bylaw supervisor regarding parking violaters?

More visibility and accountability

Keep Uplands Park as "natural" as possible

Projects are started, holes are dug, and then nothing happens for long periods (ie. the hole left in the parking area at Trafalgar Park(April/May 2025); sewer work near Central and Oliver(in 2024, I believe)).

I would prefer that graffiti was removed more quickly from the seawall at McNeill Bay, and elsewhere. It can take many weeks to be removed (ie, painted over with grey paint).

The Haul-All truck, which picks up trash from bins does a great job. Thank you for this prompt service. When the bins are allowed to get nearly full or overflow, racoons and crows can spread the bin's contents (I have seen this happen).

Safety issues should be taken seriously and not ignored that is the main reason I am leaving oak bay. Raised crosswalks are a must in dangerous intersections. The streets and sidewalks need maintained. When ever we have snow it is never ploughed on time or efficiently. Police services need to be properly educated in certain departments, I was coned by an ex tenant and the cops couldn't comprehend the forged documents so they disregarded my case.

Pay attention to the needs of all oak bay residences (ie. road maintenance & speed limit in residential streets) rather than catering only to Uplands community.

Do not ignore our concerns or complaints. Staff and council pretend to listen but hold to their own ideals and even when residents are 88% against something they move forward with the 12 %

Hire competent professional staff who we can respect and engage with, rather than be treated like peons to be swatted away when we seek engagement. Please fire those who bully and disrespect citizens of Oak Bay. You know of whom I speak. They have actively cultivated mis-trust and are a source of toxic culture at Municipal Hall. Re-train and suggest remediation for those who cannot write literate reports to Council. Their reports are agonizing for the literate citizens of Oak Bay to read.

Better upkeep of all our roads. My road, Deal St. and adjacent streets are a super bumpy ride. Ad-hock patching won't do the trick.

It is tricky to get an appropriate response to noise or fire safety violations when the business involved has personal ties to Oak Bay council. Staff then seem to assume that neighbours' complaints are simply NIMBYism rather than coming to actually check the violation. It shouldn't matter that a business owner has ties to council. Someone should come and check to see if the complaint is valid.

Asset and time monitoring, measuring and management for all resources. Undoubtedly better management of resources would improve efficiency and reduce costs. Union is likely too demanding and powerful at the public works which is costing the city dearly and should be renegotiated or operations separated into smaller non-union operations.

- -to bring parking enforcement back to an oak bay employee, subcontracting is not working as [name removed per S 22 of FOIPPA] is not responsive
- -decrease animal control bylaw officers presence (there is a cost saving to this)
- -speed up building permit issuing and ensure consistent application of rules to all residents

Tree trimming to accomodate wires for electricity etc excessive, or so it seems. Will trees grow back faster if so severely pruned. Guess it depends on species but it seems to have been particularly hard on the chestnuts on Windsor, one of the glories of the municipality. My neighbour on St Louis having fits over what seems the unnecessarily severe pruning of a tree. Were tree varieties taken into consideration by the municipality in its contract with the company that did the pruning.

To have consultation with people (and LISTEN to people) affected by proposed projects in early stages, NOT the way it was done with cycle route on Haultain / Carrick trail. To put special interest groups agenda ahead of people living in the neighborhood. The number one priority MUST be people living in the neighborhood!

Keep working the way you are ... and don't become a Victoria

The Oak Bay Rec Centre needs an overhaul. The track is falling apart and the seating is inadequate. We should be considering an outdoor pool. Turkey Head is an eyesore, Carnarvon Park is disgraceful. We need to update the indoor pool. We have the space.

There need to be a much greater emphasis on cost effectiveness to constrain the Oak Bay Budget. For instance and this is a simple example. Firmly encourage residents to dispense with mailed communications. Important documents can be retrieved from the website after an email warning. Most businesses have done this for years. Being a senior is no excuse.

Improvements to infrastructure (roads, sidewalks, street lighting, aging sewer and water mains)

Better deer control or elimination. Lower exorbitant property taxes on high end residence that get same or poorer services than others.

Sidewalks are often narrow and uneven and not friendly to people with mobility problems. There are too many road signs located in sidewalk travel paths.

Too much emphasis give to cars and parking.

Staff should be more obliging in helping you rather than trying to get rid of you by saying you that you should not be there or go to our website for your answer. For seniors, many of these people have dealt face to face all their lives and are not comfortable or unfamiliar with the computer ways. Staff are there on the taxpayers "nickel" and to serve the taxpayer rather than trying to avoid all personal interaction with the taxpayer.

More street signs at intersections are needed.

Street sweeping schedules should be organized to occur AFTER leaf pickup, not before. Signs should be placed a day ahead of time indicating "no parking" on roads to be swept, so that a decent job can be done.

Increase garbage collection frequency. Publicize how to get a broken aged garbage collection bin replaced. Streamline approvals for increased density. Improve efficiency/speed of having refund of bond for tree replacement.

Garbage collection.... 2 failures to collect in the last 4 collection periods.

Tall, dry grasses on the side of Cedar Hill Cross Road become a fire hazard. They should be mown short.

For road maintenance, finish a project before starting a new one so that the number of active sites underway and one time is minimized.

Oak Bay's failure to renew itself and grow - its population hasn't changed since the mid 1960's, and aside from older homes being torn down and replaced by new single family houses there's been minimal new public or private investment for seemingly, decades - means that the property tax base is incapable of meeting the District's clearly pressing needs. For example, street paving is literally crumbling across the municipality. Oak Bay should be a robust, dynamic community of 25,000 or 30,000.

All of my feelings about living in Oak Bay are subject to change. If my neighbour's single family home is sold and between 4-13 new homes replace it, then I would be very dissatisfied. We, the homeowners in Oak Bay are not the architects of abysmal immigration planning leading to the loss of our property rights and densification of our neighbourhoods. You are ruining a neighborhood I have literally worked my whole life to afford. As Canada is a huge landmass, this densification plan is crazy.

Improvements to active transportation infrastructure that will enable the travel needs of ALL RESIDENTS, not just those who own cars

- 1) Being much more strategic when closing roads for construction and/or maintenance so that drivers can more efficiently and safely travel.
- 2) There is an increased amount, and extent to which concrete speed bumps, divides, bike safety buffers, and one-way road travel, to the extent that it has made roadways more constricted. These measures have in my opinion, often made travel less safe and efficient, simply because there are an increased amount permanent barriers, detours, signs, etc

I am concerned about the increased administrative costs within the district

Follow through on active transportation. Quit letting emotional and uninformed reactions halt needed improvements.

Council needs to start listening to staff and stop dragging their feet, on everything from the Carnarvon Park development to the Active Transportation plan to some kind of housing plan

Cancel fall leaf program

A better website and more services available via the web site.

Provide updates on projects delays, e.g. Windsor Park playground completion, on social media.

I've typically been very happy with the services I've accessed, and am especially happy with the Parks Dept. The permit processing time to prune trees was very fast, even with a site visit included in the process.

More community policing of bylaws e.g. parking, use of laneways for personal parking/storage

Cycling infrastructure is seriously far behind.

Housing. The District should be showing leadership in building rent to income housing in the Municipality on municipal owned land.

The Refresh of Carnarvon Park is exceptionally slow.

Public Art is done well. A better job can be done by the committee- needs a more professional less amateur viewpoint.

Better basic pavement maintenance (sidewalks and roads) throughout the district. Much of the district needs repaving. However, when roads are torn up for new pipes etc the repaving eventually done is poor. Trenches are poorly filled or patched leaving roads bumpy and uneven creating hazards for cyclists and pedestrians.

Bike infrastrucutre (please get with the times).

Getting rid of unnecessary services - e.g. watering the boulevard along our street - very wasteful.

We are tired of January pick up or non at all. Give leaf crews a schedule and advise community of week to expect pick up. We have witnessed crews hanging out in back lanes, avoiding main streets and [comment removed per District's Moderation Policy]. They need to be monitored; Fairfield pick up goes smoothly with efficiency by designating specific days for pick up. Otherwise, cancel it.

Bylaw enforcement of off leash dogs. All of Oak Bay appears to be leash optional. Irresponsible dog owners have a complete disregard for the environment whether that's indigenous animals or native plants. Off leash dogs intimidate vulnerable people. Furthermore, dog faeces are left in parks putting the health of our children at risk. Is the dog owner lobby more important than the environment, respecting indigenous peoples sacred spaces and the health and safety of our most vulnerable?

Get bylaw (parking etc) to actually do the job they are paid for

What do you mean by services? Maintenance/infrastructure seems to take too much time. Public parks/rec are fantastic services. Changes to parks - for example Carnarvon - are very poor. There are no bikelines (we don't need a lot), there is no recycling in public places (desperately need some).

More frequent yard and household waste removal.

More efficient contractors used for road repairs and other infrastructure projects.

Text codes to departments to notify of issues.

Staff numbers in Oak Bay have increased significantly along with the use of consultants. This must be leading to the very significant increase in municipal taxes. It would be encouraging to see those new staff complete work in house rather than manage consultants. I believe one area of staff that has not increased and perhaps should, is Bylaw Enforcement.

Some construction projects take a very long time.

Infrastructure and road work seem to take place at a glacial pace, much more slowly and seemingly less efficiently than other jurisdictions we have lived in/visited.

- a)When a project is underway e.g., separated sewer project in Uplands, it would be helpful to residents to know how far along the project is (i.e., percentage completion), whether it's on time and on budget, and what will happen in the coming 2-3 months
- b) There is a perception that consultants are being hired to do the work residents might have reasonably expected to have been done by Oak Bay staff, who should have the necessary background and will be involved in future implementation

None to suggest at this time.

Keep aquatics facility up to date

More frequent green pick up. Garbage pick up every 2 weeks - stop using stat holidays to stretch out pick up dates. Try to coordinate new housing road closures with stormwater replacement work - very, very difficult to walk in our area let alone bike or drive.

Often documents (e.g.) PDFs don't have hyperlinks working in them, so when they refer to other District documents, plans, bylaws etc these have to be laboriously looked up separately and manually.

Better enforcement of residents to clean their yards and sidewalks

Hire someone to cull deer

Not sure.

Leaf collection needs improvement. Parks/Public Works should improve care and maintenance of verges with planting native plants including trees and shrubs. Less reliance on volunteers to remove invasive species from public parks and common areas

More school age programming, less catering to seniors, families live here too! Remove the red bar that blocks the register button when using SimpleMind (camp registration)!!!

Suggest better fall leaf pickup to avoid hazards on road as this is where most leaves are piled in spite of the rule which is not enforced. Also the verge plantings could be improved and maintenance of parks and common areas around piblic walkways could have more native plants and trees etc. Volunteers who help with these areas are wonderful but staff needs to do more. Uplands Park - more control over pathways & dog rules. Willows Beach - dog rule enforcement & clarification

Please keep the transfer station at Elgin

Keeping services for garden/garbage/recycling waste at Elgin station open long-term. It would help to add a camera to gauge wat times to help reduce traffic.

Improve the services at Willows beach, such as the more and better showers and foot wash stations.

Build bike lanes. Stop deferring the project and wasting tax dollars. Listen to your engineering group.

Bylaw enforcement is the only issue that affects me negatively every single day. It is marginally available despite an increasing need. Oak Bay has a great culture and atmosphere and is undeniably beautiful. So many aspects of living here are just the best.

For changes other than improving access to bylaw, budget transparency would be great and so would [comment removed per District's Moderation Policy]

Put hydro and cable lines underground or along back property lines

BEtter street lighting

We pay the highest taxes and everything behind the "tweed curtain" is old and falling apart. Sidewalks, roadworks, and playgrounds take years to be worked on and updated. Truly sad after living in other municipalities my whole life.

More bylaw enforcement officers

Consultation opportunities with key stakeholders who live in the area and will be directly impacted by the changes the municipality is making to please a handful of pervasive individuals who do not live in the area.

Also, commit and honour dates and timelines when municipality repair work or upgrades will be done that directly impact homeowners with regard to flooding and property value of their home.

The Oak Bay Recreation Centre is enormously valuable to the community and needs ongoing investment to ensure it can meet the needs of a growing population. Willows Beach has had too many issues with water pollution. Whose responsibility is it to address this? How can we protect the beach and keep the water clean and safe?

That things (such as the hot tub at the Rec Centre) get fixed in a timeline manner, not closed for three months plus. It's ridiculous, and clearly done for the convenience of maintenance staff, not the paying public.

We desperately need a shorefront washroom (maybe several) between Gonzales Bay and Turkey Point. It's a very popular walk in Victoria and there is nowhere for the (mostly adult) people to use. I've seen people pee in gardens and trees, Oak Bay Beach Hotel and Victoria Golf Course don't provide public access to bathrooms. Picnic and dog walkers at McNeil Bay routinely use the bushes along the shore, leaving behind paper, diapers and excrement.

I have given up on complaining about this (to police, to the mayor), but I really don't think residents should be exposed to explosive noise from cars.

Street parking, especially by construction related vehicles, needs to be addressed. Physical and visual obstruction are inconvenient and unsafe.

Get the streets smoothed out

Increase the number of handicapped parking spots and mark them clearly... and tidy up the few that do exist!

The upper section of Mitchell St. gets ignored alot when it needs snow clearing or leaf removing.

Line painting; especially crosswalks on Oak Bay avenue. King George Terrace street painting almost gone.

Monterey Avenue - from McNeil Bay towards the town area, feels like a gravel road, as do a few others in Oak Bay

Harling Point does not have any street maintenance.

No public washrooms from King George Terrace to Oak Bay marine in spite the number of people who walk along the water. The marines bathroom isn't really public.

You can provide better resources to support operating the Elgin transfer station - it often appears to be understaffed. That said, the staff that are available are typically very helpful.

Crosswalk from firehall park to Bowker creek

Fix sidewalks that have exposed ridges (ie., not smooth)

Three issues are of importance to me: road painting, water and sewage maintenance, bike lanes. I feel that road painted lane lines need to be upgraded much more frequently for safety reasons. I see that Oak Bay is maintaining water and sewage infrastructure, but I have no idea where we are in terms of the overall picture. As for bike lanes, I feel the current plan is unnecessary, BUT there is greater urgency elsewhere, esp. Cadboro Bay Rd, Oak Bay Ave and McNeil.

I report a road hazard condition aon the bike lanes (both directions) on Henderson Rd near Avondale, 3 weeks ago, no action was taken to correct the problems which is very dangerous to cyclists. Hope something can be done soon!

Please resolve a block in the storm sewer in the 1900 block of Monteith St. to assure that there will not be a reoccurance of a flood. The issue has been clearly documented; an attempt to resolve the issue has not been enacted.

More focus on walking and cycling. Enabling secondary suits and gardensuits. Have a contiued commitment that Scouts, Guides, and the ball teams are part of the Monterey Road / Firemens Park.

Keep the Elgin Road drop off site.

Do not create bike lanes with a disregard for parking for the tax payers who reside in the immediate area - especially given the addition of infill housing

Stop the insanity. the Mayor and Council are supposed to represent the views of Oak Bay citizens, not make decisions behind their backs. WE have lost the basic tenets of democracy, ie elected representatives who represent the views of their constituents, with opportunities for citizens to shape public policy. Bylaw patrols at willows for off leash dogs between May and Sept. and young cyclist who power ride on the beach walkway without regard for walkers. Traffic monitoring at crosswalks, in particular at Windsor and Beach where the 4 spoke intersection poses safety risks to pedestrians as drivers are not attentive to the various crosswalks and their impatience presents hazards daily for walkers of all ages.

Ecology and ecosystem protection is top of mind for me. Responses are slow from Parks Department. Species are disappearing (without question) as habitat is degraded. Please devote more resources to our ecological heritage.

I encourage Oak Bay to strongly support and encourage appropriate development to meet housing needs. In addition, this additional tax base is strongly needed to stabilize tax increases. Oak Bay should be looking to creative strategies to encourage developers to upgrade public infrastructure and amenities in their development area.

More visible police patrols in the village. In a short period of time traffic (vehicles and bicycles) blow through crosswalks near pedestrians, vehicles perform a U-turn in the middle of the block. many vehicles without license plate, occassional aggressive driving, cycllist riding on the sidewalk/not walking their bicycle in the crosswalk, regular distracted (cellphone) drivers, fail to stop before proceeding on to the avenue, parking in the yellow lines obstructing vision to get on the avenue

parks & recreation: chiptrails (around golf courses) should be better maintained) new chips, better drainage to prevent flooding and pooling and muddiness, more 'no dogs allowed' signs - and enforcement (esp. walking dogs all over the golf course, e.g.).

I applied to be on a committee and I never heard from anyone about it. To say I was accepted or not. When I enquired i was told I would be contacted. I wasn't.

When I emailed [name of individual removed per Section 22 of FOIPPA] to ask about the soil management station on cedar hill cross road, he initially got back to me and then I followed up with a part that he didn't answer. I haven't heard from him since. That was Mar 25, 2025. I am very concerned about the truck traffic, lack of proper signage, poor sight lines.

Remember that not everyone is able to use "technology".

Pave the roads properly. Cull deer. Respond when city workers say something needs to be done, and then do it.

Recreation activities - improve swimming options for children

Outdoor gym like pull up and dip equipment

Mayor and Councillors - Acknowledgement of residents concerns in a timely fashion.

Councillors should be bipartisan, non aligned with development lobby. Work in best interest of residents, rather than personal agenda

Staff - Hire staff who are knowledgeable of community history. Less use of non resident consultants and more resident consultation for Oak Bay issues.

Consultants are very costly and often do not understand the underlying issues and history unique to Oak Bay.

Lower property tax. Stop spending on art and bike lanes. Spend Al your effort and budget on infrastructure. The job of municipal government is to make things run well. Let philanthropy deal with arts and culture. No bike lanes. Also hold contractors accountable to time and expense. You are getting gouged by millionaire contractors. I love Oak Bay but it now costs me more than 1000 per month in property tax alone. Crazy!

Control the deer population

Develop a program of road maintenance and reconstruction to deal with the modern axle loads of heavy vehicles such as transit busses that are rapidly destroying the roads that were never designed for the amount of traffic and axle loading. Suggest putting a tax on BC Transit depending on the size/weight of bus to encourage the use of smaller, lighter busses.

My most recent connection with Oak Bay was Heat Pump installation and noise limits. Recently, I learned that the code was upgraded to make it more restrictive. I believe the new law has noise limits during the day (<50 db) and night (<45 db) which are different. I've spoken to a supplier who indicates that there are no units that would meet these limits. I think further clarification and guidance on these new restrictions would be helpful.

Restrict building developments to 3 or 4 townhouses on a single building lot. Take into consideration the lot size & impact on the community. Preserve green spaces in Oak Bay.

Not sure I understand exactly what "services" to comment on. The banks at McNeill Bay are falling to bits on one side - remedial action is needed to save the hedgerow and protect the cliff. cycling infrastructure: dedicated lanes, bike-appropriate stop signals. The only east-west artery in south Oak bay is MacNeil. It needs improvement.

Improved bike infrastructure is extremely important. Improved frequency and accessibility of public transit is also crucial. As a cyclist i often feel unsafe due to drivers moving too close to me. Affordable housing is also critical. I want to see more messaging encouraging citizens to see our unhoused and precariously housed neighbours as part of our community rather than something to fear.

Regarding beautification: The large cement "planters" in the Estevan Village area are old fashioned & ghastly. So are the cement garbage cans. This area is always busy. Replace with simpler, yet efficient, receptacles that are more up to date and modern.

I would like to see better engagement with police/block watch. Lots of turnover in this area it would seem and no continuity or touching base with Block Watch on a regular basis.

Really like having the Municipal Transfer Station.

I live near a community park. I feel the needs of the local residents are either minimized or completely discounted when special events are planned. There needs to be MUCH more careful scrutiny of how these events will impact the local community. There is often NO advance warning for locals of what will be happening. In one instance there was an issue that should have been addressed by the municipality and I was told to address my concerns directly with the organizers - not appropriate

Better timeliness in completing works projects

Oak Bay needs to listen better. Oak Bay is largely seniors - most seniors do not use social media, so it is not a fair means of communication. Communication from staff/council is VERY biased and hidden. When staff/council states that matters have been communicated, the public is largely unaware. Community engagement is severly lacking. Seems most decisions are decided before they get to the public and input is not welcome. Input on OB infrastructure should come from residents, not activists.

As a senior on a fixed income, the Recreation Centre is unaffordable, because the LIFE form isn't updated. Victoria's is more inclusive and offers more.

The months of 6:30 am noisy construction and house shaking has been hard on my blood pressure and health. Request for help went unheeded.

Infrastructure upgrades done in a methodical, timely fashion with transparent timelines/plans.

Most parks in OB need updating, our roads are horrible, our rec center needs a renovation, our OBH turf field needs bathrooms for crying out loud AND we need a new turf field! To name a few from a long list... yet our taxes continue to go up every year! Where does our \$\$ go!?

Having recently built a house, and commiserating with many others going thru same process, it has left us with a v Negative view of the staff in this dep. if we, in the private sector did our jobs this poorly, inefficiently and without accountability we'd be fired. The restaurant here parks a commercial white truck in front of their property and 2 other gardening commercial trucks in front of the neighbours around them vs in their own alloted parking. This is against the bylaw but never enforced by the district. Not fair to the neighbours.

If the Yard closes, I will have to stop recycling things not collected from the street. I have a car, but I drive less and less, and use public transit more. Now I can't walk or cycle in with items. Surely it was never a safety hazard! Then, give us some hours when cars are not allowed!

Closer supervision of permits (e.g. Prospect Place - removal of rock wall), also it appears developers are favored over neighbourhood concerns when a waver is needed to allow something outside the building code), lack of enforcement of airbnb limits (not sure if there's a policy but definitely there are folks who find them a nuisance in their neighbourhood for example up to 5 operate on Lincoln). Neighbours are reluctant to make complaints.

Or, maybe an "Oak Festival" celebrating everything Oak: songs, tree tours & tales, oak-crafts etc. Less senior focus! (I'm 71 and its too OLD for me!)

Much faster notification of unusual water usage. We had a broken water line that resulted in a huge bill but weren't informed of it in a timely manner. We weren't aware of it for few months, resulting in a huge bill that was only partly reduced.

Would love to have more public outreach from the municipal government - what services can you provide, what do you spend your money on? I've learned a lot just from this survey and I feel advertising your public services and being transparent about decisions and spending would help me feel more connected to this community. I'd love to get more involved but meetings are advertised last minute in the oak bay news. Do you record these? If so where can I access? More outreach is needed!

- -There are way too many municipal employees.
- -It feels like District employees run our community, not our Mayor and Councillors.
- -Don't discriminate against those who work '9-5' jobs for advisory committees.
- -More accountability for Councillors. Trying to ram through ridiculous projects without proper public consultation. They have been poor at public engagement, bar [comment partially severed per Section 22 of FOIPPA]
- -Bar said [comment partially severed per Section 22 of FOIPPA], the others enjoy listening to themselves speak.

Better active transportation infrastructure is needed. OB has fallen behind Victoria and Saanich in cycling infrastructure, especially bicycle lanes. OB is full of walkers yet many streets lack sidewalks.

OB micromanages building permits and is very slow or refuses to issue development permits. The fact that a new OCP is in preparation is used as an excuse not to issue development permits.

Better response to service requests/suggestions such as sidewalk maintenance, broken/burnt road illumination poles, road conditions.

Bring back the garbage collection website or an alert, the pdf is hard to access and keep track of.

Cull the deer

Fix McNeil bay waterfront that is washing into ocean during big winter storms.

Plastic bag recycling at pickup.

Squash courts

Allow rental suites in houses that have the old low basements - make permitting easier!

Given the massive amount of foliage it would be nice to have two rounds of leaf pick up.

Affordable housing, better public transportation, better public parking particularly along and around Oak Bay Avenue and other heavily used areas

It would be nice to have a single online location for current and future services in a rolled up summary format. This way if there are areas of interest or something that might have a direct effect then we can be informed appropriately

More timely boulevard care

bike lanes

amalgamation! Ridiculous to have a municipality for 20,000 people, and ridiculous that a few voices can block any kind of progress.

Pickleball courts

As a lay person it appears council acquiesces to increased costs from the province, regional authority, unions etc The population of Oak Bay has remained relatively flat. I sense staffing numbers and equipment /technology costs are increasing. Ai, improved technology, better equipment should result in reduced staffing and lower costs. I do not believe that the council is ensuring that efficiencies and effective cost saving are being perused,

More work on pedestrian and cyclist infrastructure. For example, Uplands neighbourhood is dangerous due to lack of sidewalks and poor streetlights. Dorset Rd at Midland and Beach Ave at Dorset are intersections that could use crosswalks. Safe cycling routes near transportation corridors like Oak Bay Ave and Cadboro Bay Rd would be an improvement for both residents and visitors.

Inappropriate stop sign proposed on Eastdowne/Estevan corner

Maintenance of sidewalks is lacking. There are weeds and grasses growing on sidewalks and curbs throughout the municipality. This causes tripping hazards and is unsightly. Simple application of cleaning vinegar can clear this up.

I never have the street sweeper on my street any more. I have to sweep my own curb all the time. Lack of street cleaning contributes to a more unkempt look.

High density housing permits and in-law suites appear to be approved without sufficient impact assessment on traffic and neighbourhoods. A new vision and road plan is required. Traffic calming/routing is useless and needless on many streets and creates more stress than calm. While on other streets that really need traffic calming and reduced speeds,

nothing has happened. Speed limits need to be enforced and red light running needs to be addressed.

start paving the roads - they are a disgrace

more bike lanes - i don't enjoy biking in Oak Bay and am glad to get out of the municipality where I can use the wonderful infrastructure in neighbouring municipalities. get rid of the oak bay marina - and restore the waterfront so that all can enjoy there are too many golf courses - the waterfront areas would make lovely parks.

Better service when community members call in for information. I have called a number of times with request for information and been told someone will call me back and no one ever does.

Insist council members answer questions clearly and honestly.

Why doesn't Oak Bay follow Saanich and Victoria in terms of aligning municipal animal control bylaws with Federal laws? Both Saanich and Victoria require dogs be leashed on beaches; Oak Bay does not. This means Animal Control Services has no jurisdiction on Oak Bay beaches. It is an embarrassment, and it is unconscionable.

Would like to see Bylaw enforce: RV Vehicles parked on residential property, marina parking lot (camping overnight), over grown yards. Bylaw needs to work shifts or hours to ensure over night camping is enforced.

My main problems are with the enforcement of the Bylaws of Oak Bay. As Oak Bay only has one Bylaw officer, he can't meet the needs of the community. There are no proactive measures taken - only reactive. We live on Gonzales Bay and we have had continual problems with noise. And as to the other bylaws - drinking, smoking, dogs on the beach, etc - these are never addressed. A bylaw presence on a regular rotation would help to mitigate these issues. As well as longer hours.

Taxes should be cut, hiring should be frozen and staff cut, there should be better control on union staff who take holidays in summer when parks and infrastructure work is needed. Building permit oversight needs to be more reasonable and far less expensive, Roads and sidewalks that are in terrible shape (eg Monterey school, Hampshire Rd sidewalks south of OB Ave) need to be addressed, street lighting in south Oak Bay needs to be added. Traffic patterns need to be readdressed as OB Ave is clogged

no more bike lanes. Enough is enough, they are a traffic hazzard to both cars and persons crossing the streets at the crosswalks or intersections.

Better road maintenance

reinstate single family unit zoning do not change our neighbourhood with multi-unit condos beside our homes

Progress on certain issues/improvements can be slow. ie: Secondary suite decision took forever, future of the Turkey Head space.

The transfer station on Elgin rd is a huge benefit to the population of Oak Bay. But over the last few years it has become a mess. Hard to use, rude staff, confusing rules for parking etc. The table for leaving perfectly good items seems to be going to the wayside. Which is a shame as we are in a place in the world where people should be able to upcycle usable things instead of having them thrown away. Please go back to the way it used to be.

Expand items for street-side recycling pickup, increase the frequency of leaf pickup (both business and residential areas), improve snow-removal on sidewalks (e.g. wider paths so pedestrians traveling in opposite directions can pass, make sure businesses and apartment buildings clear their sidewalks), improve sports fields and their facilities.

More direct communication with a resident on the current status of the resident's unanswered question i.e. why is it taking Staff so long to respond to an unanswered question?

Leaf pick up is always far behind schedule, and when it finally is done, it's done so poorly that the boulevards take until the following (late) spring to fully recover from the gouging of machinery and die-back from leaf piles left too long.

Quality of workmanship and materials being used is substandard, often a new sidewalk patch just cracks because of bad workmanship, often new pavement does not have the design to last and withstand, potholes are filled superficially which only survive a season, roads are massage boards and makes riding a bicycle very uncomfortable, for street markings we use simple paint whereas others use lasting marking material, I could go on

Shrubbery encroaches on so many sidewalks making them narrow and sometimes impassable. Yellow paint on corners needs also needs attention.

Our road pavement is deplorable. Our house shakes when drivers drive over the indent in the road.

Lower property taxes

I find it difficult to find the minutes listed for the Town Hall or future council meetings, or when it is going to be posted. The website isn't very intuitive to find these things.

I support council and staff efforts to respond to provincial efforts to improve housing access. more child care, swimming lesson spots

Take better care of your deer! Decrease population. OB needs to find a solution because the current bleeding heart solutions are not working. I feel unsafe in parks during rutting season.

Cycling infrastructure in Oak Bya is almost non-existent!

Parks staff need to be more familiar with Oak Bay tree bylaws, and follow them.

Oak Bay isn't protecting its residents from Provincial housing mandates and Bill 44. The multiplexes being built are far too big for their lots and they are harming the community. Oak Bay already has very high population density by Canadian standards. We don't have the streets or parking to support densification like this. We're already in a major doctor shortage. This will only make it worse!

Pay contractors to do ALL road work improvements. Municipal employees take way too long and cost us way too much money. Stop spending money on unnecessary bike lanes when people have been cycling on the proposed streets safely for years.

I would like a smaller curbside green bin for kitchen waste. Walk/Don't Walk signals could be better for visually impaired, i.e.: audible verbal words rather than bird sounds. Development permit applications should require developers to clearly state neighbour impacts during construction, duration of construction and efforts to avoid damage to and devaluation of neighbouring property. We need an independent scientific health and safety study of deep rock blasting in confined residential areas.

Road construction excavations need to be much better/safer covered in off hours. Our road is ridiculously pot holed - up to three layers of hand patches. Not repaved for decades!

Respond to written communications from Oak Bay residents instead of ignoring them with no acknowledgement.

I would appreciate updates to some of Oak Bay's facilities. The women's change room at the pool could have more cribs for caregivers to use for the baby/infant sessions. The washrooms at Willows Beach park could also be better maintained. Additionally, it is disappointing to see the lack of progress with revamping Carnarvon Park. There was public engagement in 2019 and the park has become very run-down while waiting for the new plan and redevelopment.

The process to re-envision the marina area needs to move ahead with some urgency. I can't understand why the previous process which obtained lots of public input never went ahead. Time for leadership on this.

- -Have a more efficient schedule for road construction/facility work so that there are not so many roads being worked on all at the same time. Very frustrating!
- -Maybe less municipal employees scheduled to do a "on man job"
- -Better supervision on-site for employees/work being done.

Knowledge about who to call when, prime example, our neighbours across the street shut our whole no-exit street down (Sattlelite St, by hotel) so they could have a huge crane deliver roofing materials, 2 days notice, but 70 people live on this street and it shouldn't be allowed. What if there were emergencies. We are all seniors!

Ongoing repaving of older streets, not the current piecemeal approach where egregious holes are more or less filled-in. For example, cycle up Margate Street from Newport to Beach Drive-pretty appalling maintenance.

Make at least some attempt at cycling infrastructure. Remove the raised flower boxes that protrude into Oak Bay avenue at Wilmot Place. They create unnecessary pinch points for cyclists.

Quicker response re: permit applications

Stormwater retention bylaw to protect Bowker Creek based on Saanich bylaw 7501 (schedule H) which has benefitted Oak Bay since 1996.

Form and character design guidelines must be included in new OCP the built "feel" of O.B. from insensitive and unskilled designs in upcoming wave of densification, and to give staff proper tools for evaluating applications.

Keep trucks off Granite St. It is a residential street. Process building permits quicker

Council has to make the decisions that they are elected to make and once made the decision is made it should not come up for review when the next council is elected. Politics is tough and no matter what decisions are made not everyone will like them but we cannot keep having previous council decisions overturned by the next incoming group.

Change the underlying bureaucratic philosophy from "it's easier to just say no" to "find a way to yes". Eliminate all municipal employees from working from home. Back in the office Monday to Friday. Our company, a large air transportation company, was a private sector industry leader in working from home 20 years ago. The data unequivocally proved that, at best, about 25% of workers have the same or better productivity working from home.

Work with the community you are there to serve instead of taking a "we know best what's good for you" attitude.

More resources to support denser housing

Focus needs to be on resolving deferred infrastructure maintenance. Let's not waste time on the nice-to-haves like bike lanes but concentrate on the need-to-haves.

Is there any way to limit recreational users of facilities to avoid overcrowding? For example, the swimming pool for lane swimming gets so crowded it isn't possible some mornings. I have paid to use it but there isn't room in a lane to actually swim for more than a few strokes before running into others. I try to wait in the 'exercise' area on the left for people to leave but sometimes give up after 15 or 20 minutes. At least I can move around and do something in the exercise area.

Please improve, replace sidewalks. Very dangerous, especially for seniors.

Open library Sunday afternoons. Typically a family day and the library is closed; very unfriendly and short-sighted. O.B. encourages a healthy lifestyle then closes the library on Sundays.

Would like to see road improvements for both bikes and cars. Currently too many pot holes! Would like to see hedges trimmed back so that sidewalks are clear to be walked on (eg. east side of Hampshire, just north of McNeil.) Don't allow cars to park close to intersections as it's dangerous (cannot see around them to get into the intersection safely.)

Stop spending money on downgrades to existing infrastructure. Roads should not be changed. There have been no changes that have been an improvement, and I am not happy that our cars are forced onto side streets. No money should be spent on bicycle lanes especially since they are for the benefit of Saanich people. It was a continual dinner joke with all four of my kids about how stupid adults are that they build and ride in dangerous bike lanes when the kids find the many safer routes.

I'd like to see white lines painted on heavily used streets. Was pleased to see the lines at Monterey Centre parking lot were finally painted. These should be regularly maintained After speaking to Oak Bay Police about the frequency of people (drivers) not stopping at STOP signs. Nothing has changed. There have been several times where I was almost hit by a car because they did not stop. This is a big problem.

- 1. Never again close the pool at the Rec Centre during the summer when children are out of school and families would enjoy the facility.
- 2. Have some sense of esthetics when considering property development. What type of structure actually fits into this community setting. This has been sadly lacking and we will be stuck with it for decades.
- 3. Pave the streets that look like logging roads.

The District indulges TOO MUCH community involvement in matters relating to transportation planning, zoning, development and the like. These are areas where research on best practices exists. Let staff act on that to serve the interests of the District as a whole instead of trying to listen to citizens who are motivated by selfish interest.

Dramatically improve communications with neighbourhoods, especially when individual neighbourhoods are going to be impacted by infrastructure work or by particular Council or staff decisions. Dramatically improve how senior staff at Mun Hall engage with residents. Improve opportunities for collaboration between residents and staff. Provide better training to members and Council on their roles on the ADP and APC Land Use. Improve registration and spaces for swimming lessons and after school care.

Spot checks and surprise patrols should curb this behaviour.

4 way stop signs at the corner of Newport and Windsor Improve washrooms and services to the washrooms at Willows beach.

Oak Bay has become too bureaucratic and is therefore operating inefficiently. The increase in staffing has been accompanied by a decrease in service levels. Oak Bay needs to slim down and also streamline the website to improve navigation. Ideally, there should be one general search box offering a multiple-choice of topics to enable redirection of queries to the correct persons. Currently, the website is a spiders-web of confusing information so it is impossible to know who to contact.

Interdepartmental communication and knowledge of departmental affairs.

We need to remove barriers to housing development (e.g. reduce parking requirements, actively facilitate inlaw suites development and remove house garage requirements for single detached homes). We also need to better support active transportation by providing way more protected cycling lanes to enhance safety and reduce climate impact.

Late last year, contacted the council to find out more information about development planned in my location. I got no response to my calls and e mails to staff and council. After almost a year, I still don't have a response.

Amalgamate with other greater Victoria cities.

Getting balance on tree management - loss of trees for development and protecting residents/structures from failing Garry Oakes.

Getting sound, sustainable plan for Marina parking for lot area with First Nations and community residents.

Speed up process with YIHA on development of seniors housing/services at Oak Bay Lodge site.

Sidewalks in my neighbourhood are scary/dangerous, cannot be navigated by wheelchairs/powerchairs (too many cracks + tree roots make pavement uneven) we have to drive to parts of Oak Bay, where sidewalks are in better shape (wider, no buckled pavement) for walking.

More user friendly sign up process for recreational programs

Deer continue to be a safety issue. Recently I was chased by a doe while walking my small dog one block from Oak Bay Avenue in the Village. My dog was ignoring the deer and did not provoke the interaction. Only an oncoming vehicle interrupted the situation. It is not easy to avoid these situations because one does not know where fawns are hidden and how to retreat away from them. Crossing the street can just amplify the danger.

Provide more affordable housing and multi-unit housing instead of single family detached homes. Rezone all areas including Uplands to allow multi-unit housing instead of mansions.

Bylaw should be more active in patrolling cars parked in residential roads. Our street (Epworth) is chalked-block full of cars, making it challenging to get from one end to the other without stopping multiple times to let other cars through.

Improve efficiency and cutting red tape. Using citizen volunteers in meaningful ways. Adopt a culture of "yes and here's how we can do it" rather than "no way". Consider new and innovative ways rather than reverting to status quo because "it's always been done that way." Make citizens better aware of situation eg ongoing storm sewer repair due to age/deferred maintenance so projects/tax increases are better understood.

Just the basics - have staff pick up phone and respond to emails. I am waiting for two months for a response. Pick up garbage and recycling everytime you are supposed. Fix the roads - the potholes are horrible. Replace lightbulbs in your streetlights.

Bumpy roads. Pls fix

Address the deer problem. Also an emerging rabbit problem. Re-examine your driveway bylaw. As I understand it, Oak Bay is the only municipality to require concrete driveways, and ban asphalt driveways. Asphalt is more cost effective and more durable. One concern is of the recycling depot in Oak Bay. I do hope that there will always be a recycling depot otherwise there will be Materials that can be recycled going into the garbage. If the recycling depot is stopped in Oak Bay then curb side pick up of recyclables such as soft plastics, needs to be added. The centre has been very convenient especially for small and large metal items, paint and battery recycling. The compostable recycling is well used and valued by the community.

More publicly accessible medical clinics. Yes, it's not municipal jurisdiction, but I just wanted to register the complaint on the lack of medical services for those without a GP.

What specifically is being achieved to meet Gov't housing requirements

I have noticed at times that the Development Application Tracker does not always show addresses where I see work being done when I am out walking in Oak Bay. I am not sure if homeowners are failing to complete the required applications and the work is not known to the municipality, or if the app is not being updated with everything.

I'm not sure why there are often several Oak Bay trucks parked at a job site but only 1 or 2 people working while other staff members are standing around watching. This doesn't give me confidence that my very high tax dollars are being effectively used. Does every staff member have a truck of their own?

Be more proactive to find solutions for moving pickleball from Canarvon Park.

Oak Bay needs to take care of "the necessary" before spending on the "nice to have", so maintenance of aging infrastructure/construction of new infrastructure, especially to meet the Province's housing requirements, is a priority. Snow/ice removal from sidewalks, as required by the Community Charter and Oak Bay's bylaws, is inadequate. Deer control is woefully lacking. What about emergency preparedness, which is ... what? Bike lanes should NOT be a priority.

Traffic calming.

There are places where quiet roads have excess traffic, poor visibility, city buses can't get through, poor signage with all the detours, multiple need for signs and getting people to slow down, just accidents waiting to happen!

I think your website could be better organized. It's difficult to find the right department/person. I also think if possible summarizing key decisions in a single place would be helpful, rather than making residents read through meeting minutes.

Willows Beach is the most popular in district. South end gets clean up of logs - but north end is completely ignored. Elderly and people with children teeter on logs trying to get to the beach. When I queried about installing speed bumps &/or lowering speed limits the response was "it's a collector road". Well, that designation should be changed! How does that happen???

More opportunities for local, neighbourhood engagement on a more regular basis, planned annually. Town Hall meetings on specific topics. More significant messaging about the recent provincial government legislation that impacts density and local housing development.

The district continues to kick the can down the road for infrastructure projects. We have the worst roads, sidewalks, and parks in the greater Victoria area. The district continues to claim budget responsibility while pushing massive expensive projects on to the next generation. When neighboring districts are doing improvement projects we should team up to reduce costs, not decline the updates and claim fiscal responsibly.

More bike lanes

Re-think the rationale for charging and collecting boulevard watering fee as it currently is. Boulevard watering in the Summer months clashes with the notion of water conservation and landscaping best practices. It is fiscally unfair. Either charge all residents or incorporate into public works or parks and recreation budget. Status quo is no longer acceptable.

Better street sweeping

Get the bikeways finished.

Oak bay seems to make decisions, with little to no community input, that affect residents negatively. When there's an actual problem, there's no response.

Listen to oak bay citizens more. Stop doing whatever you feel like. You represent us don't forget! We do not want Oak bay being densities and filled with condos and suites.

Strongly discourage development applications that do not meet Council bylaws and regulations.

Encourage community engagement that embraces and promotes community.

Do not undertake expensive bike way and bike lane developments (especially Foul Bay, Cadboro and Oak Bay Ave)

Take down overly sentimental abd disrespectful "art" (whale bones in shape of a heart) at Oak Bays entrance. Also stop putting up "art" that interferes with the evidence based healing effect of purely natural experiences of our ocean sides and gardens.

Consultation with local residents regarding infill housing applications needed!!

- 1. Oak Bay needs to focus more on maintaining/upgrading infrastructure:
- roads and sidewalks are in very bad shape except Beach Drive, Oak Bay Ave. and St Ann St.
- water mains are leaking through asphalt
- 2. In case of major changes to bylaws (4plex), public should be informed ahead of time and have an input.
- 3. The district should implement a plan that regulates density (i.e., choose more density along main corridors instead of letting contractors decide and build 4plexes everywhere)

 More exploration of appropriate revenue-generating and cost-sharing opportunities with neighbouring municipalities, other levels of government, private sector and philanthropy

 It feels like a small town with bigger city challenges: infrastructure, density demands, strong opinions amongst residents.

It's a challenging time. I hope council and staff are accessing resources to make efficient, wise decisions that will serve the municipality well into the future.

A small example: partner with federal projects to plant trees. There is funding available.

One thing I noticed taking this survey is that some of the questions were worded in such way to make it impossible to know what I was satisfied or unsatisfied with. As an a example "Am I happy with animal control". If I say I'm dissatisfied am I dissatisfied because there is not enough animal control or too much animal control. Otherwise I think it's great that Oak Bay is asking our opinion.

From what I have read in the newspaper or heard from other residents, OB does not process building requests (even simple reno requests) very quickly, and at a much slower rate that other municipalities. I understand that changes to the review and approval process is underway (fewer things going to Council, allowing staff to make approvals, more staff, etc.) I would certainly support those changes.

The new website is not as easy to navigate as the old one. Mayor and CAO do not always answer emails. There should be an automatic reply that they send out to say that your email has been received and then a follow-up response within two to three days.

No comment

Overhaul the before and after school care programmes at the Neighbourhood Learning Centre. There should be spaces available for every family who needs the service. If staff is needed, hire them. If higher pay is needed, charge more for the service and pay your workers. Operate it like a business and follow supply and demand rather than a focus on affordability. The impact this has on families in our community is immense if they can't get their kids into the program, which is the case currently.

Better upkeep of the limited bicycle safety infrastructure that exists. Better monitoring of off-leash dogs in areas where dogs are not allowed off leash.

Transportation: provide a short left lane at Bee and Cadboro Bay Road. Terrible backups. There's room for it.

Provide a crosswalk and flashing lights with pedestrian crossing going from Bowker Creek trail end across to Fire Hall. Many sidewalk areas on Oak Bay Avenue are too narrow and obstructed by power poles, detracting from walkability.

Be more transparent on social media, website, etc. with updates.

- -side walks, curbs, especially as many older citizens are using (and must for stability) walking + wheeled mobility aids and 'protections'
- -traffic noise, speed, size of vehicles, especially along Oak Bay Ave. Often heavy, large, almost empty buses.
- bikers 'take priority on the road' attitude especially Oak Bay Ave. which has so much automobile traffic

Other bike routes.

Staff at the Elgin Transfer station should be instructed no to refer to the people using the transfer station as "do... ba.." foul vulgar language. Male staff member uses this term when speaking to a female staff member, about a male user. It was loud and clear for me - a female - user to hear. Disgusting.

Improved hours at Elgin Rd. Transfer station. Having hours available Sunday. Better planning and engagement on new housing developments - build multi family housing in the appropriate areas of oak bay.

The CRD war on smoking was bizarre & we now have 2 vape shops on Avenue. Every day countless citizens, including camp/after-school groups, children on bikes, adults, seniors with walkers, etc, take there life in their hands making this crossing. OB gives us wonderful access to green spaces along the Creek Pathway + at the Park, Allotment Gdns, Willows Beach, etc. But you need to connect them in a safe way. You have already lost a municipal worker, a young father with children, to this dangerous corner. I can see children riding to/from school every day attempting to make this crossing safely. Why has nothing been done? Please don't wat for another fatality (entirely preventable) Please install a crosswalk similar to the one on Hamshire. This needs to be a priority (along with safe crosssing at entrance to Windsor Park) 2. Bylaw enforcement: non smoking (and no druge use) bylaws need to be enforced at Willows Beach - there are people smoking marijuana up and down the beach every day, with children around and now I have seen drug users set up lean-to shelters too + use drugs, with no one stopping them. WHere are the police? They seem to only be in their vehicles, rarely on foot or bike, patrolling the actual beach. It is not fair for children to be exposed to drug use (or adults too, for that matter) when they are simply trying to enjoy being out in nature. If yuo don't stop it now, we will become known as a place where drug users can go + use drugs w/immunity because no one stops them. What is the point of having bylaws if they are not enforced? The police need to become a presence on the actual beach. Please don't let this community become anymore unsafe than it already is. It used to feel like the safest place to live. That is changing drastically. Thank you for taking action now to care about your citizens.

More daycare and out of school care options! We moved to oak bay a year ago and when I contacted the daycare (Paddington) I was told there was a 3 year waitlist. Our daughter will start school in Sept 26. no-one has been able to explain to me how I get her into the only out-of-school care for Willows. The website indicates preference is given to those already in the Daycare. We are worried that we aren't goin to get her in. We both work full time and there are no grandparents to help out.

Permitting process needs to be more timely!

Enormous wait times cause additional expense.

Poor communication. Irrational decisions.

Direct more spending to underground infrastructure, sidewalks and playgrounds (not bike lanes)

I don't know if this comes under services, but I would like to see more infill development and more attention paid to seniors who have lived in Oak Bay for many years and may not be able to stay when downsizing - not enough condos/apartments/smaller developments.

Don't limit public consultation to special interest groups.

We need more pushed public announcements (via emails, newspaper ads, and posters/flyers) about opportunities for townhalls, information sharing, and the Official Community Plan Process. The OCP survey was deeply flawed and I understand was closed off early - before the July 2nd deadline? The displays regarding densification proposals & the new provincial laws re: blanket densification did not constitute consultation, and we not spread out to offer maximum opportunity for citizens to attend.

If the municipality is struggling financially., there needs to be greater Transparency demanded from service providers and not lame acceptance of ever increasing costs for service delivery. Our share of E-Comm 911 service is a good example. Where are the service stats? Can we justify the price per call? How many true emergency calls? We should demand accountability for cost of service across all departments.

Complete infrastructure projects in a more timely way by working at night or on weekends. Businesses seem to have been adversely affected by the protracted Sinclair Rd and Cadboro Bay Rd rebuild.

Keep helping police to remove suspicious people from the streets, monitor speed limits, limit density and size of new constructions.

Adhere to the leaf pick-up schedule more closely.

Road repaving

The highest importance is the continued planting of urban trees and bringing much more attention - newspapers, posters, social media - to what Oak Bay is doing and how residents can become involved. Thank you.

I would urge the mayor and council to respond - even with a cursory acknowledgement - to correspondence addressed to them from resident electors. 30 of us wrote to the mayor and council in 2024 and have yet to receive a reply. The correspondence was delivered by hand but ignored.

Council's inability to lead on housing and infill issues, and defer and deflect to the Province, is reprehensible.

Please continue to improve by-law enforcement. The new proactive enforcement of short term rentals is appreciated. For building permits, we'd like to see a reasonable dollar figure for renovations requiring a permit and clear safety-based reasons for permits. (\$500 is ridiculous and seems to be ignored throughout the city.) We also see a need for municipal involvement in affordable housing (rental or owner occupied) in Oak Bay that is suitable for seniors living independently.

Regarding the infill projects on Pentland (three story 4-plex), St Patrick (apparently a three story 3-plex) and Bowker (also three stories?)... I find those buildings horrendous and ridiculous solutions to densification. I know the municipality has been pressured by the housing minister but there must be something that council can do to stand up to the mandates. I would be incensed if I lived in an adjacent lot.

The road surfaces are in very poor condition. Riding a bicycle on many of Oak Bay's streets can be quite uncomfortable since the surface can be very broken. You have to constantly watch that your bicycle wheels don't get caught in a crack that could cause you to fall off.

Oak Bay is awesome. Please remedy the following: there is no sidewalk on the South side of Windsor. To take the bus, one must walk in the street. My 85 year old mother must walk in the street to get to her bus. Wheelchairs are not accommodated. Also, please widen the sidewalks on the north side of oak Bay Ave. Our narrow sidewalks are a glaring defect of the village. Thank you!
